

**December 2022 DisCo Remittances**

1. Discos' expected overall payment performance (based on the Minimum Remittance Order by NERC) is 82.28% but overall DisCo payment performance achieved at the time of generating this report is 62.65% representing 76.15% of the MRO requirements.
2. With the implementation of NERC's order on Regulatory Net-Offs, only Yola DisCo attained the requirements of the Minimum Remittance Order.
3. Subsequent Payments are expected from DisCos with outstanding MRO payments
