

July 2022 DisCo Remittances

- 1. Discos' expected overall payment performance (based on the Minimum Remittance Order by NERC) is 82.46% but overall DisCo payment performance achieved at the time of generating this report is 81.21% representing 98.48% of the MRO requirements.
- 2. With the implementation of NERC's order on Regulatory Net-Offs, four DisCos (Benin, Kaduna, Kano, Port-Harcourt Discos) have not satisfied the requirements of the Minimum Remittance Order.
- 3. Subsequent Payments are expected from DisCos with outstanding MRO payments.
- 4. For DisCos that have surpassed the month's Minimum Remittance obligation, a review of the annual performance will be carried out in respect of the excess payment.
